It allows participants to design their own support plans and choose the services and providers that best meet their needs. Participants have more control over the budget for their supports and can make decisions about how those funds are used. The goal of the program is to increase independence and improve the quality of life for individuals with disabilities.

How can a Financial Management Service Provider (FMS) help?

A financial service provider helps participants manage the budget for their supports and assists with the implementation of their individualized support plans. This may include tasks such as processing invoices, monitoring the budget, and ensuring that funds are being used in accordance with the participant's plan. It also provides support to participants in navigating the program, including helping them understand financial management responsibilities and how to access and use program funds.
